

UPDATE: BID TERM CORRECTED FOR PACKAGE 1: APRIL 1, 2018 – APRIL 30, 2018 FOR PORT OF MORGAN TO NORTH HAYDEN

In accordance with Section 6.26.2 of its tariff, Northern Border Pipeline Company is providing notification of available capacity on its system.

Northern Border Pipeline Company is holding a bid period that will close at 2:00 PM CST on March 26, 2018. In order to submit a bid, Shippers should complete the attached bid form and submit by email to Lonnie_Lozano@TransCanada.com and Sean_McDonald@TransCanada.com

Bidders are advised that while Northern Border is not obligated to accept Bids at a rate less than the Maximum Rate, for a shorter term than posted, or for a shorter path than the posted path, Northern Border may consider Bids fitting these descriptions. Parties desiring to submit a Bid must satisfy the creditworthiness provisions set forth in Northern Border's tariff. Bids must indicate the Start Date, Termination Date, Reservation Rate, Transportation Path, and the Quantity in receipt Dkt per day. Bids will be evaluated in accordance with Method A set forth in Subsection 6.27.6.1(a) of Northern Border's tariff. In the event there is more than one Best Bid, capacity will be allocated on a pro rata basis to the Bidders submitting a Best Bid.

The capacity is identified below by Term, Transportation Path, and Maximum Receipt Quantity (MRQ) in receipt Dkt per day.

Capacity will be awarded based upon Northern Border's calculation of the bid or combination of bids that result in the highest present value. Northern Border reserves the right to accept any one bid or combination of bids that will result in the largest aggregate present value for the packages offered. Northern Border reserves the right to reject any bid or request that conflicts with the terms of this open season or its FERC Gas Tariff.
