Dear Ms. Bose:

Pursuant to Part 154 of the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations,<sup>1</sup> and in compliance with a Letter Order ("Letter Order") issued September 22, 2010, in Docket No. RP10-658-000, *et al.*,<sup>2</sup> ANR Storage Company ("ANR Storage"), Blue Lake Gas Storage Company ("Blue Lake"), Tuscarora Gas Transmission Company ("Tuscarora"), Great Lakes Gas Transmission Limited Partnership ("Great Lakes"), Gas Transmission Northwest ("GTN"), and Northern Border Pipeline Company ("Northern Border") (collectively, "TransCanada Pipelines"), are proposing a schedule, as set forth herein, indicating when each pipeline will file the required revisions to certain tariff records within their baseline electronic FERC Gas Tariffs ("Baseline Tariffs"), which were previously filed to comply with Order No. 714.<sup>3</sup>

## Statement of Nature, Reasons and Basis for Filing

The Baseline Tariffs for each of the TransCanada Pipelines were filed according to the staggered dates set forth in Order No. 714.<sup>4</sup> The Letter Order accepted TransCanada Pipelines' Baseline Tariffs to become effective on the dates requested by each company, subject to each company refile certain tariff records. The Commission stated that the companies' proposed tariff record section titles were based on various sections of the tariff.<sup>5</sup> However, the Commission noted that in each of the proposed Baseline Tariffs submitted by TransCanada Pipelines, the tariff record section titles identifying the various sections do not refer to specific numerical sections identified in the table of contents and elsewhere in the tariff text. The lack of a specific numerical reference within a tariff record section title results in confusion and difficulty in navigating the table of contents on the Commission's eTariff Viewer. The Commission, therefore, directed TransCanada Pipelines to refile certain tariff records to include the applicable section number in the tariff record section title. Furthermore, the Commission

directed TransCanada Pipelines to submit a schedule indicating when, prior to December 31, 2010, each pipeline will file its revised tariff records.

In addition to the pipelines listed in the Commission’s Letter Order, North Baja Pipeline, LLC (“North Baja”) has also been included in the schedule submitted herein. On April 28, 2010, North Baja filed its baseline tariff in Docket No. RP10-660-000. North Baja’s baseline tariff was accepted on August 10, 2010, as proposed.<sup>6</sup> Because North Baja’s baseline tariff was filed in a format similar to TransCanada Pipelines’ Baseline Tariffs, the lack of section numbers in its tariff record section titles will result in the same difficulties in viewing its tariff on the eTariff Viewer. Therefore, North Baja is being added to the schedule as well, and its revised tariff records will be filed by December 31, 2010.

Pursuant to the Commission’s Letter Order, please find below a schedule outlining when each pipeline will file the revised tariff records. TransCanada will endeavor to make such filings at an earlier date if possible.
